ZERO today announced organization change, change of a consolidated subsidiary's trade name and personnel change that were resolved as below at the Board of Directors' Meeting held today.

1. Organization Change (Effective October 1, 2017)

As part of our program to promote efforts to make the regional blocks on a nationwide basis with the aim of reorganizing our nation-wide logistics network, we are going to make the following organization changes in conjunction with the establishment effective October 1 of this year of ZERO PLUS CHUBU CO., LTD. and ZERO PLUS NISHI-NIHON CO., LTD. that oversee transportation operations in the Chubu Block and Nishi-Nihon Block, respectively.

- (1) We will integrate the function of the Company's Shizuoka CSC (※), Toyohashi CSC, Nagoya CSC and Kanazawa CSC into Nissan Shizuoka Worknet Co., Ltd., a consolidated Zero subsidiary (President: Yasuhiro Ogawa), which is due to change its trade name to 'ZERO PLUS CHUBU CO., LTD., effective October 1, 2017.
